


Comment now on the CPG: Evaluation of the Neck Mass in Adults

Clinical Practice Guideline (Update): Tonsillectomy in Children

The original 2011 Tonsillectomy in Children guideline assessment has been completed. The Guideline Update Group (GUG) leadership has determined this will be a minor revision. We are currently recruiting panel members from the following organizations: American Society of Anesthesiologists (ASA), American Academy of Sleep Medicine (AASM), American Academy of Family Physicians – Family Practice (AAFP), American Academy of Pediatrics (AAP), American Society of Pediatric Otolaryngology (ASPO), Consumers United for Evidence-Based Healthcare (CUE), Infectious Disease Society of America (IDSA), and Society of Otorhinolaryngology and Head-Neck Nurses (SOHN) - Advanced Practice Nursing. Clinical Consensus Statement: Sinus Ostial Dilation in Adults

The topic of Sinus Ostial Dilation was approved for clinical consensus statement development by the Guidelines Task Force (GTF) at the November 2016 meeting. We are currently recruiting expert panel members from American Rhinologic Society, American Academy of Otolaryngic Allergy, American Academy of Allergy, Asthma & Immunology, Triological Society, AAO-HNS Board of Governors, and several AAO-HNS Committees [Physician Payment Policy (3P) Work Group; Rhinology and Paranasal Sinus; Allergy, Asthma, and Immunology; Medical Devices and Drugs; and Imaging]. The first conference call will be held March 15. An abstract has been submitted for presentation consideration at the AAO-HNSF 2017 Annual Meeting & OTO Experience. AHRQ Releases Tonsillectomy Evidence Reviews



UPDATE: Adapting the AAO-HNSF Guidelines to Mexico

While attending the 2015 Evidence-Based Guidelines Affecting Policy, Practice and Stakeholders (E-GAPPS II) Meeting in New York, **Richard M. Rosenfeld, MD, MPH**, met with Jose Luis Mayorga Butrón, Otorrinolaringología y Cirugía de Cabeza y Cuello, Instituto Nacional de Pediatría and discussed a collaboration between the AAO-HNSF and the Mexican Society of Otolaryngology and HNS, **SMORL**, to adapt three of the AAO-HNSF guidelines (Tympanostomy Tubes, Tinnitus, and Adult Sinusitis).

The **ADAPTE Collaboration**'s systematic approach to adapting guidelines based on cultural and organizational differences has been utilized. SMORL has completed the manuscripts and is in the process of submitting to *Otolaryngology–Head and Neck Surgery*. An abstract has also been submitted for presentation consideration at the AAO-HNSF 2017 Annual Meeting & OTO Experience as part of the International Symposium.

College of American Pathology: HPV Testing in HNSCC Guideline

In 2013, James W. Rocco, MD, PhD, was appointed to the College of American

Pathologists (CAP) HPV Testing in Head and Neck Carcinomas guideline development panel. CAP anticipates submission of the new guideline to *Archives of Pathology & Laboratory Medicine* this spring and publication early summer. The draft guidelines were presented at the CAP and the American Society of Cytopathology 2016 annual meetings. American Society for Clinical Pathology and the American Society of Hematology: Evidence-based Guideline for the Work-up of Malignant Lymphoma

In January 2017, Edward Fundakowski, MD, was nominated to serve on the new guideline development group. A primary goal of this guideline will be evidence-based recommendations for the pre-analytic phase of testing with a focus on specimen requirements. A secondary goal will be to provide evidence-based guidance on which ancillary testing and clinical parameters ensure a level of diagnostic certainty to provide actionable results. More details will be shared once they become available.

American Society of Plastic Surgeons: Post-Mohs Reconstruction Guideline

In January, Travis T. Tollefson, MD, MPH, was nominated to serve on the new guideline development group. The guideline is intended to be used by the multidisciplinary teams that provide care for patients undergoing a reconstructive procedure following Mohs surgery and is also intended to serve as a resource for healthcare practitioners and other guideline developers. More details will be shared once they become available.

CUE - Consumers United for Evidence-Based Healthcare

In 2011, the AAO-HNSF began including consumer advocates on our multi-disciplinary guideline panels. Their participation has proved to be invaluable to the CPG development and update processes. AAO-HNSF works regularly with CUE to assist with recruiting consumer advocates to serve on the clinical practice guideline panels.
