AAO-HNS Supports Greater Access to Hearing Aids with Patient Safety Preserved

The Over-the-Counter Hearing Aid Act of 2017 (H.R. 1652/S. 670) was recently introduced by U.S. Representatives Marsha Blackburn (R-TN) and Joseph Kennedy III (D-MA) and U.S. Senators Elizabeth Warren (D-MA), Charles Grassley (R-IA), Johnny Isakson (R-GA), and Maggie Hassan (D-NH). The <u>AAO-HNS supports access</u> to over-the-counter (OTC) hearing aids for adults with mild-to-moderate hearing loss when paired with appropriate patient safety and consumer protections. To ensure patient safety is preserved, the <u>Academy stands by its recommendation</u> regarding the benefits of a medical evaluation by a physician, followed by a standardized hearing test (via a hearing health professional or appropriate online/technological source), before an individual purchases any type of basic hearing aid or other FDA-regulated assistive hearing device.

Action Alert: Urge Your Federal Lawmakers to Cosponsor IPAB Repeal Legislation

The Protecting Seniors' Access to Medicare Act of 2017 (H.R. 849/S. 260) was recently re-introduced in the 115th Congress by U.S. Representative Phil Roe, MD (R-TN), and U.S. Senator John Cornyn (R-TX). The legislation would repeal the Independent Payment Advisory Board (IPAB), thereby ensuring Congress retains its rightful oversight of Medicare payment policies. The AAO-HNS <u>supports repeal of the IPAB</u> and encourages all members to <u>contact their federal lawmakers today!</u>

Legislative & Political Reports

EHDI Reauthorization Legislation Introduced

Legislation (H.R. 1539/S. 652) to reauthorize the Early Hearing Detection and Intervention (EHDI) program was recently re-introduced by U.S. Representatives Brett Guthrie (R-KY) and Doris Matsui (D-CA) and U.S. Senators Rob Portman (R-OH) and Tim Kaine (D-VA). The EHDI program supports statewide plans that identify infants/children with hearing loss and provides the appropriate early intervention services. The AAO-HNS supports

H.R. 1539/S. 652 and is working with the hearing health community to urge swift passage of this important legislation.

ACA Repeal Legislation Stalls Temporarily

On Friday, March 24, the "American Health Care Act (AHCA)" was pulled from consideration prior to a vote on the floor of the U.S. House of Representatives. As Republican leaders revisit their strategy to repeal and replace the Affordable Care Act, the AAO-HNS will continue its conversations with lawmakers, advocating for affordable access to care for patients and reduced administrative burdens on physicians.

AAO-HNS Joins Stakeholders in Opposing H.R. 1136

The AAO-HNS joined 42 healthcare organizations in <u>signing a letter opposing</u> the "FDA Deeming Authority Clarity Act" (H.R. 1136). By exempting e-cigarettes, cigars, and other tobacco products from an important product review designed to protect public health, the bill would significantly weaken FDA's ability to take prompt action to protect children from the thousands of fruit-and candy-flavored e-cigarettes and cigars.

AAO-HNS Submits Comments for Upcoming FTC Workshop on Hearing Healthcare

On April 6, the AAO-HNS <u>submitted comments</u> to the Federal Trade Commission (FTC) in preparation for an April 18 workshop titled, "Now Hear This: Competition, Innovation, and Consumer Protection Issues in Hearing Health Care." The Academy's comment letter outlines consumer protection recommendations relating to various assistive hearing devices.

Academy Leaders Visit Capitol Hill

Academy leaders <u>traveled to Capitol Hill</u> as part of the <u>AAO-HNS/F 2017 Leadership Forum & BOG Spring Meeting</u>. Participants met with the offices of Speaker Paul Ryan (R-WI) and Minority Leader Nancy Pelosi (D-CA), as well as Republican and Democrat staff from key committees in the House and Senate. Topics discussed included MACRA, EHDI, OTC hearing aids, IPAB repeal, and other issues of importance to the specialty.
