Register Now: May 9 Webinar on Quality Payment Program

CMS is [hosting a webinar](#) on **May 9 at 1:00 pm (ET)** to discuss participation criteria for Year Two of its Quality Payment Program. In this session, the agency will provide an overview of conditions used to determine a clinician’s inclusion in the 2018 Merit-based Incentive Payment System (MIPS) and Advanced Alternative Payment Models (APMs).

Advocacy Efforts on Critical Drug Shortages

The AAO-HNS and other impacted specialties recently held a conference call with the FDA to request additional agency attention to address shortages of lidocaine, lidocaine with epinephrine, and other local anesthetics. Given the serious adverse impact these shortages have on Academy members and the patients they serve, the AAO-HNS [will continue its work with the FDA](#) on regulatory efforts to resolve these and other drug supply issues.
