AAO-HNS Spearheads Opposition to Audiology Physician Status

A coalition of more than 120 physician organizations, led by the AAO-HNS, <u>sent a letter</u> to leaders in the U.S. House of Representatives expressing strong opposition to the "Audiology Patient Choice Act" (H.R. 2276). If enacted, the federal bill would provide audiologists with unlimited direct access to Medicare patients without a physician referral, as well as limited license "physician" status under the Medicare program. The AAO-HNS thanks the state and local otolaryngology societies that signed the letter and welcomes any additional signatories. Legislative & Political Reports

Ways & Means Committee Announces Regulatory Relief Initiative

The Health Subcommittee of the U.S. House of Representatives Ways and Means Committee recently announced the creation of the "Provider Statutory and Regulatory Relief Initiative," an effort designed to identify opportunities to reduce legislative and regulatory burdens on Medicare providers. The Committee is seeking feedback on how

Congress can deliver statutory and regulatory relief by working with the Department of Health and Human Services and Centers for Medicare and Medicaid Services. The AAO-HNS is preparing comments for submission to the Committee and looks forward to working with lawmakers as they identify and explore opportunities for regulatory relief.

U.S. Senate Confirms Surgeon General Nominee Jerome Adams, MD

On August 3, the U.S. Senate voted to confirm the nomination of Jerome Adams, MD to serve as the next U.S. Surgeon General. The AAO-HNS supported Dr. Adams' nomination and recently <u>sent a letter</u> to Senate leaders urging a swift confirmation.

Health Reform Efforts Fail in Senate

After a dramatic week that culminated in an all-night "vote-a-rama," the U.S. Senate failed to pass legislation to repeal the Affordable Care Act (ACA). While Senate leadership has expressed a desire to "move past healthcare," a bipartisan group of lawmakers have been meeting to brainstorm a legislative package designed to stabilize the ACA marketplace and implement other reforms to the law. The AAO-HNS is continuing to monitor healthcare reform efforts and will provide additional information as it becomes available.

User Fee Reauthorization with OTC Hearing Aid Provisions Advances to President

The U.S. House of Representatives and U.S. Senate recently passed legislation to reauthorize the FDA's User Fee Agreements. The legislation (H.R. 2430) was amended by the U.S. House Committee on Energy and Commerce to include provisions relating to the over-the-counter sale of hearing aids, and the AAO-HNS was successful in securing amendment language relating to labeling requirements and "medically treatable causes of hearing loss." The bill will now head to the President for signature. Once signed into law, the FDA will begin the regulatory process to create a category of OTC hearing aids. The AAO-HNS will be closely monitoring the FDA's progress and will provide comments during the rulemaking process.

Other News

FDA Announces Major Shift in Tobacco Policy

The FDA <u>recently announced</u> a new comprehensive plan for tobacco and nicotine regulation that will serve as a multi-year roadmap to better protect kids and significantly reduce tobacco-related disease and death. As part of the FDA's policy shift, the agency will also delay the deadlines established for oversight of electronic cigarettes, cigars, and previously unregulated tobacco products for five years, while additional information and stakeholder feedback is collected.
