## The 115th Congress Convenes with an Ambitious Agenda

The 115th Congress convened on Tuesday, January 3, with lawmakers facing a list of complicated priorities. Most notable is Congress' goal to deliver legislation repealing the Affordable Care Act (ACA) to President-elect Trump's desk within his first 100 days in office. In addition to monitoring ACA-related activities, the Academy will focus its federal legislative advocacy efforts on securing re-introduction of AAO-HNS-supported bills (newborn hearing screening/EHDI and federal Truth in Advertising) and monitoring legislative efforts related to the potential sale of over-the-counter or "basic" hearing aids for individuals with mild to moderate hearing loss.

#### AAO-HNS Comments to CMS on MIPS and APM Final Rule

On December 19, 2016, the Academy submitted comments to the Centers for Medicare & Medicaid Services (CMS)

in response to the Merit-based Incentive Payment System (MIPS) and Alternative Payment Model (APM) Final Rule. The Academy commented on the reduced reporting requirements for the transition year; MIPS performance category criteria and scoring; Qualified Clinical Data Registry (QCDR) and quality measure reporting requirements; and applicability of APMs to otolaryngologists. FDA Announces New Guidance on Hearing Aid Medical Evaluations and Waivers

On December 7, 2016, the AAO-HNS participated in a hearing healthcare stakeholder meeting hosted by the National Academy of Medicine (NAM), formerly the IOM. The session served as a follow-up to the June 2016 NAM report on hearing healthcare services. At the meeting, the Food & Drug Administration (FDA) announced it will implement the third recommendation of the NAM report and will no longer enforce the requirement that individuals, age 18 years and older, receive a medical evaluation or sign a waiver prior to purchasing most hearing aids. Although the guidance is effective immediately, the FDA will accept public comments. The AAO-HNS provided comments to the FDA on this topic in June 2016 and is reviewing the effect of the new guidance on current practices, as well as its potential impact on "direct access" legislation and Medicare's physician referral requirements.
