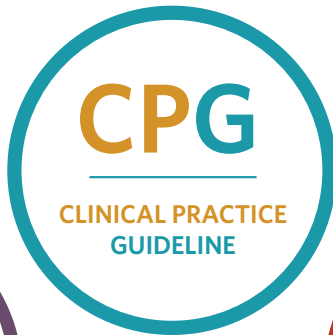

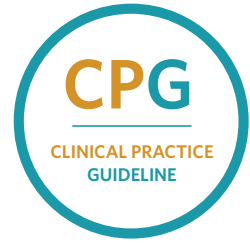

Consensus Statements should not be confused with a formal evidence review that is the standard for a Clinical Practice Guideline.

The mission of the CORE grants program is to support the most meritorious research in otolaryngology-head and neck surgery, promote mentorship and the education of young investigators to prepare competitive grant applications, and to prepare more surgeon-scientists to serve as peer reviewers for the National Institutes of Health (NIH) and other research agencies.

Since the inception of CORE, the AAO-HNSF and other participating specialty societies have awarded more than 700 grants totaling over \$12 million.
