AAO-HNS Physician Leaders Advocate for the Specialty on Capitol Hill

As part of the AAO-HNS/F 2019 Leadership Forum & BOG Spring Meeting, physician leaders from the AAO-HNS visited more than 25 House of Representative and Senate offices on Monday, April 29. The meetings focused on policy issues of critical importance to the specialty, including scope of practice, “surprise” medical billing, prior authorization, and comprehensive tobacco control legislation.

AAO-HNS Requests Congressional Support for GME Funding Increase

The AAO-HNS [joined more than 65 organizations](#) in urging members of the U.S. House of Representatives and Senate to support and co-sponsor “The Resident Physician Shortage Reduction Act of 2019” (H.R. 1763/S. 348). This bipartisan legislation would provide a responsible increase in Medicare support for graduate medical education (GME) to address the national physician workforce shortage.

*Contributions to ENT PAC are not deductible as charitable contributions for federal income tax purposes. Contributions are voluntary, and all members of the American Academy of Otolaryngology-Head and Neck Surgery have the right to refuse to contribute without reprisal. Federal law prohibits ENT PAC from accepting contributions from foreign nationals. By law, if your contributions are made using a personal check or credit card, ENT PAC may use your contribution only to support candidates in federal elections. All corporate contributions to ENT PAC will be used for educational and administrative fees of ENT PAC, and other activities permissible under federal law. Federal law requires ENT PAC to use its best efforts to collect and report the name, mailing address, occupation, and the name of the employer of individuals whose contributions exceed \$200 in a calendar year.
