# AAO-HNS Works to Secure Patient Safety Provisions in OTC Hearing Aid Legislation

On May 18, the House Energy & Commerce Committee's Subcommittee on Health "marked-up" the Food & Drug Administration (FDA) User Fee reauthorization bill. During the mark-up, the bill was amended to include language instructing the FDA to create a new class of over-the-counter hearing aids for adults with mild-to-moderate hearing loss. The bill will likely be considered by the full Committee the week of June 5, and the AAO-HNS is working with Committee staff to secure additional amendments pertaining to patient safety.

### **Action Request**

## Sign-on Request: Oppose Audiology Physician Status Legislation

The AAO-HNS is currently collecting signatories for a sign-on letter in opposition to H.R. 2276. If enacted, this federal legislation would provide audiologists with "direct access" to Medicare patients without a physician referral, as well as amend Title XVIII of the Social Security Act to include audiologists in the definition of "physician." Past AAO-HNS letters on this topic have generated more than 120 signatories, and we hope to secure the same level of support this year. ### **PROJECT 535 In Action**

In the first half of 2017, PROJECT 535 participants made their voices heard opposing H.R. 2276, an audiology scope of practice bill, and encouraged their U.S. Representatives to support legislation that would repeal the Independent Payment Advisory Board (IPAB). PROJECT 535 volunteers have also weighed in on global surgical codes and urged support for legislation to reauthorize the Early Hearing Detection and Intervention (EHDI) Act. PROJECT 535 continues to make an impact, but with only 60 percent coverage of all 535 U.S. House and Senate districts, it is imperative that the Academy grow its team of grassroots advocates. # **Legislative & Political Reports**

### **CBO** "Scores" the AHCA

The non-partisan Congressional Budget Office (CBO) recently released its analysis of the American Health Care Act (AHCA). If enacted, the CBO estimates the AHCA would lower the deficit by \$119 billion over 10 years, while 23 million more people would be uninsured by the year 2026. Additionally, the CBO estimates that insurance premiums will increase in the years before 2020, as compared to current law. After the year 2020, the price of premiums will depend on several factors, including waivers granted to states and changes to markets. The U.S. Senate is expected to substantially amend, if not re-write, the House-passed version of the AHCA. As this process moves forward, the AAO-HNS is continuing to engage with lawmakers, advocating for affordable access to care for patients and reduced administrative burdens on physicians.

# **Congressional Committee Examines Status of Medicare**

On May 18, Legislative Advocacy staff attended a House Ways & Means Health Subcommittee hearing examining the "Current Status of the Medicare Program, Payment Systems, and Extenders." Mark Miller, PhD, Executive Director of the Medicare Payment Advisory Commission (MedPAC), served as the sole witness, <u>providing testimony</u> to the Committee regarding MedPAC's March 2017 Report to Congress.

## **Coalition Supports Expansion of Physician-Owned Hospitals**

The AAO-HNS joined 55 stakeholders, including national, state, and local physician groups and organizations, in <u>sending a letter</u> to members of the U.S. House of Representatives in support of the "Patient Access to Higher Quality Health Care Act of 2017" (H.R. 1156). If enacted, H.R. 1156 would repeal the current moratorium on expansion and construction of physician-owned hospitals.
