

ASPS18: Shared-decision making for post-operative management of discomfort following Rhinoplasty

High Priority: Yes; Opioid-related Measure*

Percentage of patients aged 15 years and older who had a rhinoplasty procedure who had documentation of a pre-operative shared-decision making strategy for multi-modal post-operative management of discomfort. Definitions: Documentation of discussion of at least two mechanisms of pain management from the following terms or phrases (one term or phrase from each list) will meet the measure:

Non-opioid analgesics: Non-narcotic/Non-opioid, Acetaminophen/Tylenol, Cox-II inhibitor (Celecoxib),

Local/Marcaine/Block, Anxiolytic, Tramadol, NSAID/ibuprofen Non-systemic: Ice/Cooling, Elevation, Rest, Mindfulness, Meditation

Denominator:

All patients aged 15 years and older who had a rhinoplasty procedure.

Denominator Exclusions:

Denominator Exceptions:

Patient reasons for not taking a non-opioid analgesic.

Numerator:

Patients who had documentation of a pre-operative shared-decision making strategy for multi-modal post-operative management of discomfort.

Definitions: Non-opioid analgesics: Non-narcotic/Non-opioid, Acetaminophen/Tylenol, Cox-II inhibitor (Celecoxib),

Local/Marcaine/Block, Anxiolytic, Tramadol, NSAID/ibuprofen

Non-systemic: Ice/Cooling, Elevation, Rest, Mindfulness, Meditation
