

2017 AAO-HNS Socioeconomic Survey and AOA Practice Benchmarking Survey



INTRODUCTION AND OVERVIEW OF FINDINGS

In 2017, the American Academy of Otolaryngology-Head and Neck Surgery (AAO-HNS) and the Association of Otolaryngology Administrators (AOA) collaborated to survey their members and practices on Calendar Year 2016 data. Historically, this study has provided valuable data for physicians and practice administrators to compare their practices' data to other practices of similar size.

The AAO-HNS and the AOA worked with Somerset CPAs and Advisors, P.C. to undertake this study. Invitations and reminders were sent during the period of June 12 – July 21, 2017. There was extensive follow-up with non-respondents to encourage participation, and individual follow-up with respondents who reported data that required additional confirmation to ensure accuracy of the final report.

The AAO-HNS portion of the survey was sent to 7,459 physicians, of which 759 physicians responded, yielding a 10 percent response rate. The AOA portion of the survey was distributed among 707 practices, of which 59 practices responded at least partially, yielding a response rate of 8.4 percent.

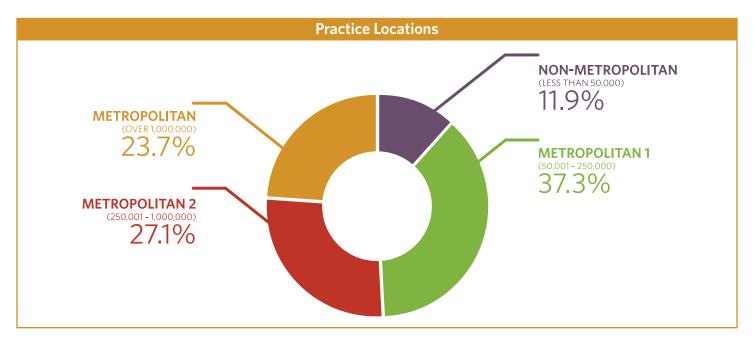
- **Physician Profile:** The average respondent was 53 years of age, had 20 years of medical practice, and planned to retire by age 67.
- Strategic Initiatives: Most common responses for practices in the next 12-24 months included 1) Groups utilize patient satisfaction or patient outcome reporting tools, 2) Groups are looking to hire a new physician, and 3) Groups would recommend their EHR Vendor to their colleague.
- **Top EHR Use:** The top two Practice Management Systems include Greenway Medical Technologies and Centricity Practice Solutions.
- **Services Provided**: Diagnostic audiology testing, hearing aid sales, and balloon sinuplasty are the highest percent of ancillary services provided by practices. General ENT and Pediatric ENT are the highest percent of services provided.

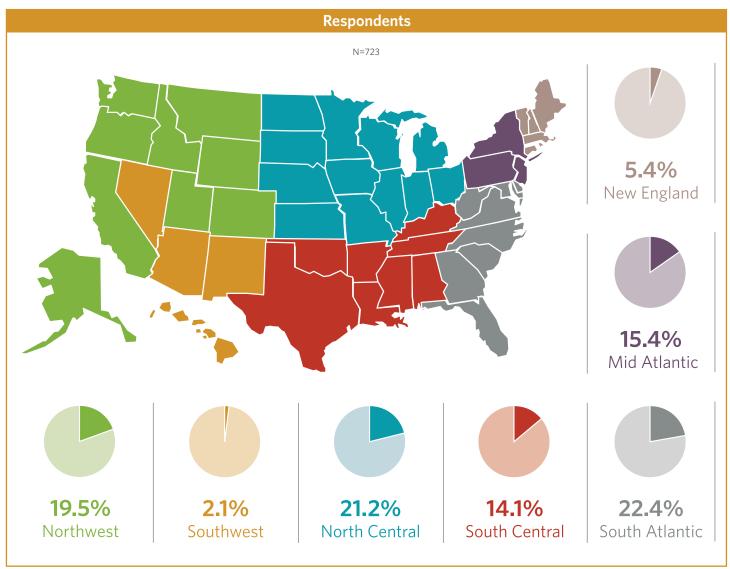

DEFINITIONS

Count	The total number of practice responses for a line item.
Mean	The arithmetic average calculated by summing the data and dividing by the count.
Median	The midpoint of all responses when arrayed from lowest to highest.
25 percentile	The value where one quarter (25 percent) of the responses are lower and the remainder greater.
75 percentile	The value where three quarters (75 percent) of the responses are lower and the remainder greater.
90 percentile	The value where nine tenths (90 percent) of the responses are lower and the remainder greater.
FTE	Full-Time Equivalent. Full-time equivalent employees equal the number of employees on full-time schedules plus the number of employees on part-time schedules converted to a full-time basis. The number of full-time equivalent employees in each industry is the product of the total number of employees and the ratio of average weekly hours per employee for all employees to average weekly hours per employee on full-time schedules. (Bureau of Economic Analysis, U.S. Department of Commerce)
Fiscal Year Ending (FYE)	Fiscal year is defined as any continuous 12-month period used by a business or government as its accounting period. For this survey, the period used was Fiscal Year 2015.
Total Gross Charges	Gross charges are the full value (undiscounted rates) of service provided.
Total Gross Receipts	The actual receipts collected before refunds are issued.
Total Refunds	The total amount of receipts returned to an insurance company and/or patient.
Total Adjustments	The amount by which Total Gross Charges are reduced due to write-offs from contractual discounts, bad debts, etc.
Net Charges	The total gross charges less contractual allowances.

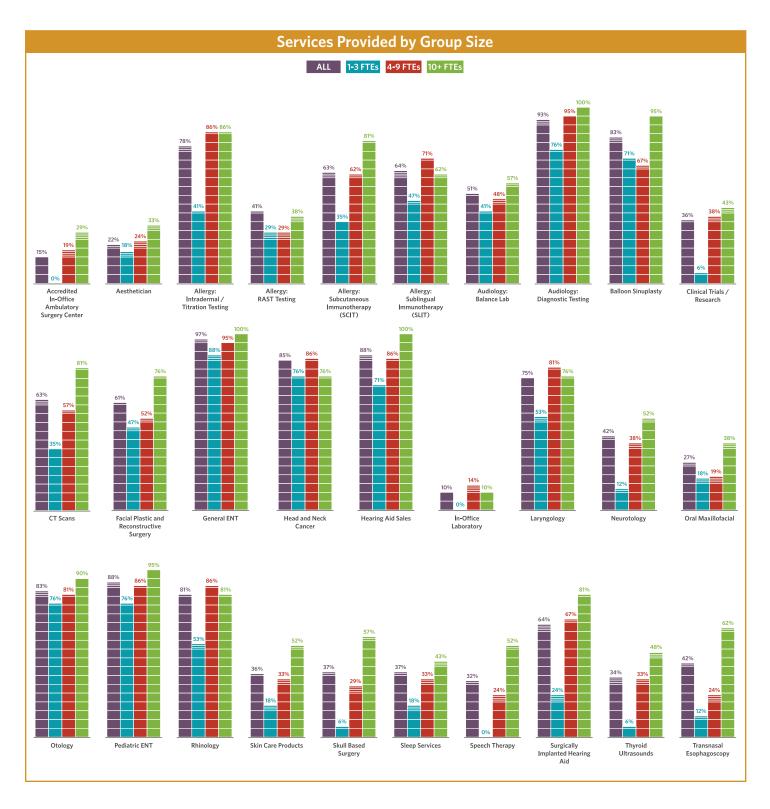

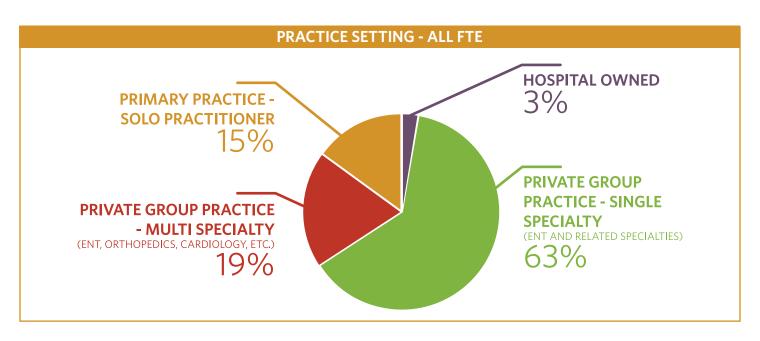

PER FTE PHYSICIAN BY GROUP SIZE

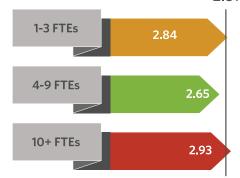

PER FTE PHYSICIAN BY GROUP SIZE

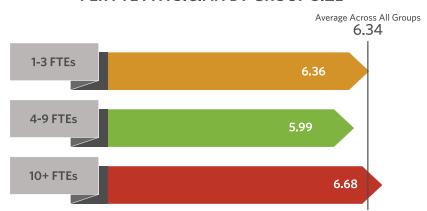
