CONTINUING EDUCATION CREDIT

The AAO-HNSF clearly distinguishes non-CME Informational/ Education Programs from AAO-HNSF CME. The AAO-HNSF does not provide continuing education credit for Corporate Satellite Symposium. AAO-HNSF requires Corporate Satellite Symposium to comply with ACCME Standards when CME is offered by a third-party accredited provider. If continuing education credit is offered, the accredited provider must be listed on the application form.

KEY AAO-HNSF LEADERS

 - ii) If the company cancels participation on or after August 13, 2021 will not receive a refund.
