Lead Story

The 117th Congress and New Administration: First 100 Days

With the Democratic party now in control of the White House, Senate, and House of Representatives, President Biden is leading the Administration and Congress' response to the ongoing COVID-19 pandemic. The President's \$1.9 trillion COVID relief package passed the House of Representatives on February 27. This legislation has an uphill battle in the Senate, given the party's slim majority. Confirmation hearings for President Biden's nominations for Xavier Becerra to serve as Secretary of Health and Human Services (HHS) and Chiquita Brooks-LaSure to serve as the Administrator for the Centers for Medicare & Medicaid Services (CMS) have commenced in the Senate. Once these two key Administration posts are filled, we can expect Congressional debate on pivotal healthcare issues to begin in earnest. The Academy is eager to build off the legislative successes from the previous Congress to further protect and bolster otolaryngologist-head and neck surgeons and their patients.

Legislative and Political Reports

New AMA Resource Available on the "No Surprises Act"

On December 27, 2020, the "No Surprises Act" was signed into law. This legislation, which enacts changes to federal law to protect patients from the financial impact of unanticipated medical bills, was included in the Consolidated Appropriations Act, 2021. The new law takes effect on January 1, 2022, and includes provisions on price transparency, provider directories, and patient financial protections that will impact AAO-HNS members and their patients. The American Medical Association has <u>released an initial guide</u> to the major provisions included in this legislation.

AAO-HNS Opposes Additional Medicare Payment Cut

The AAO-HNS joined the American Medical Association and dozens of other national and state medical societies in urging Congress to pass H.R. 315, the "Medicare Sequester COVID Moratorium Act." This bipartisan legislation would suspend the automatic 2% Medicare sequester payment cut for the duration of the COVID-19 public health emergency. While we applaud Congress for recognizing the financial strain that COVID-19 is placing on physician practices and for enacting a temporary sequester moratorium and subsequent extension to March 31, 2021, it is critical that Congress further postpone the sequester. The Advocacy network can expect to see an AAO-HNS grassroots campaign in support of H.R. 315, the "Medicare Sequester COVID Moratorium Act" soon.

ENT PAC "First 50" Update

Thanks to the support of so many AAO-HNS members, we have reached our "First 50" goal! These generous contributions will help ENT PAC protect otolaryngologist-head and neck surgeons and their patients across the

Regulatory Reports

SBA Currently Accepting PPP Applications for Small Businesses with 20 or Fewer Employees

In an effort to support more small businesses through the Paycheck Protection Program (PPP), the U.S. Small Business Administration (SBA) is offering <u>PPP loans</u> to businesses with fewer than 20 employees and sole proprietors **only** now through Tuesday, March 9, 2021, at 5:00 pm (ET). <u>Additional program changes</u>, designed to make access to PPP loans more equitable, were recently announced as well.

New Coding Resources Available: Top 100 ENT Services for 2021

The AAO-HNS has prepared two charts for members outlining the top 100 Current Procedural Terminology codes reported by providers with the designation "4-Otolaryngology" within the Medicare database. The two charts describe the top 100 ENT codes billed in a physician office and the hospital outpatient department. The information is based on 2019 Medicare claims data, which is the most recent year for which data is available.

AAO-HNS Continues Medicare Advocacy Efforts on Payment for PPE

On February 1, the AAO-HNS <u>submitted a comment letter</u> to the Centers for Medicare & Medicaid Services (CMS) regarding its interim final policy on coding and payment for personal protective equipment (PPE) and other infection control costs during the COVID-19 public health emergency (PHE). The Academy's comments reiterated our previous recommendation that CMS immediately implement and separately pay for CPT code 99072. Fair reimbursement for this code is required to recognize physicians' increased expenses due to infection control practices necessary to care for patients during the ongoing PHE.

Action Requested

Strengthening PROJECT 535

Given the ambitious legislative agenda for the 117th Congress, it's more important than ever for the Academy to strengthen its "key contacts" network via PROJECT 535. In addition to the Academy's overall advocacy efforts, PROJECT 535 volunteers help reinforce our message by establishing one-to-one relationships with federal elected officials. This additional element of constituent-based outreach amplifies our advocacy efforts when Congress debates major issues affecting the specialty. The commitment is minimal, but the impact is immense.
