### AAO-HNS Supports Introduction of Comprehensive Tobacco Control Legislation

The AAO-HNS [joined more than 50 public health organizations in expressing strong support](#) for the *Reversing the Youth Tobacco Epidemic Act of 2019 (H.R. 2339)*. This new legislation, introduced by U.S. Representatives Frank Pallone (D-NJ) and Donna Shalala (D-FL), addresses youth use of tobacco products. The bill is one of several bipartisan proposals introduced in the U.S. House of Representatives and Senate attempting to curb the youth tobacco epidemic.

### AAO-HNS Co-Sponsors Education Briefing on Capitol Hill

On May 29, the AAO-HNS cosponsored a briefing on Capitol Hill with the Friends of the Congressional Hearing Health Caucus. At the briefing, [Academy member Richard K. Gurgel, MD, spoke](#) on the public health impact of hearing loss in older adults. Dr. Gurgel, AAO-HNS Advocacy staff, and Caucus members also met with offices on Capitol Hill to discuss a range of issues concerning adult hearing loss and the Medicare program.

### Surprise Billing Gains Traction on Capitol Hill

As part of the AAO-HNS/F 2019 Leadership Forum & BOG Spring Meeting last month, AAO-HNS physician leaders advocated on Capitol Hill for legislative solutions to “surprise billing” to better protect patients. Surprise billing solutions continue to gain momentum on Capitol Hill as multiple pieces of legislation have been introduced in the U.S. House and Senate. AAO-HNS Member Debara L. Tucci, MD, MS, MBA, [has been selected to lead the National Institute on Deafness and Other Communication Disorders \(NIDCD\) as its new director](#). Dr. Tucci is currently a professor of surgery and director of the cochlear implant program in the Division of Head and Neck Surgery & Communication Sciences at Duke University. A long-time, active member of the AAO-HNS, she is the recipient of the AAO-HNS Distinguished Service Award and Jerome C. Goldstein, MD Public Service Award. Dr. Tucci also served on the AAO-HNS Research Advisory Board, Board of Directors, Executive Committee, and numerous subcommittees. She is expected to join NIH on September 3, 2019.

#### **Academy Comments on Moda Health Reimbursement Policy**

On May 21, the AAO-HNS commented on Moda Health’s reimbursement policy on postoperative sinus endoscopy and/or debridement procedures. The [comment letter](#) focused on separate reimbursement for sinus endoscopy and nasal debridement. The letter also requested policy clarifications about impacted and related procedures, routine follow-up wound care, and debridement prevalence.

#### **Major Alabama Payer Opts to Maintain Reimbursement for Cone Beam CT Scans**

In December 2017, one of Alabama’s largest health insurance carriers announced a drastic reimbursement reduction for cone beam computed tomography (CT) scans, effective January 2018. Coordinated advocacy efforts occurring over the course of the next 18 months eventually resulted in a significant win for practicing otolaryngology-head and neck surgeons in the state of Alabama.
