## Lead Story

### Senate Advances Legislation to Suspend Medicare Payment Cuts

On March 25 the Senate passed legislation (H.R. 1868), by a vote of 90-2, to extend the 2% Medicare sequester moratorium set to expire on April 1. The amended bill provides a nine-month extension of the moratorium through December 31. The House of Representatives passed a different version of the legislation earlier this month that would both extend the moratorium through the end of the pandemic and eliminate an additional 4 percent Medicare sequester scheduled to take effect on January 1, 2022. Consequently, the House must pass the Senate language when it returns from its Spring recess in mid-April. The House is expected to vote favorably on the revised language, and the Centers for Medicare & Medicaid Services [announced](#) that it will suspend processing April claims until the bill is enacted into law.

The AAO-HNS thanks members of our ENT Advocacy network who responded to our "Call to Action" and raised their voice to prevent this arbitrary cut. ## Legislative and Political Reports

### Audiology Groups Announce Joint Effort to Pass Direct Access Legislation

The Academy of Doctors of Audiology (ADA), the American Speech-Language Hearing Association (ASHA), and the American Academy of Audiology (AAA) recently announced introduction of federal legislation that would grant audiologists "direct access" to Medicare patients, eliminating the long-standing physician referral requirement in current law. [H.R. 1587, the "Medicare Audiologist Access and Services Act \(MAASA\) of 2021"](#) was introduced by Representatives Tom Rice (R-SC) and Matt Cartwright (D-PA) on March 3, 2021. For patient safety reasons, the AAO-HNS strongly opposes this legislation. Hearing and balance disorders are medical conditions that require a full patient history, physical examination, and medical diagnosis by an MD/DO. In addition to spearheading a physician community opposition letter, the AAO-HNS is activating a grassroots response through PROJECT 535 and updating our "Call to Action" to send pre-written messages to lawmakers. ### AAO-HNS Advocates for Prohibition of Flavored Tobacco Products

On March 3, the AAO-HNS joined a number of physician and public health organizations in [submitting a letter](#) to Acting U.S. Food and Drug Administration Commissioner, Janet Woodcock, MD, urging prompt action by the agency to prohibit menthol cigarettes and other non-tobacco flavored tobacco products, including e-cigarettes and cigars. The letter notes that flavored products are particularly attractive to young people and

lead to increased tobacco initiation. The Academy has long advocated for banning these products and will continue to support tobacco prevention and cessation efforts.

## Senate Confirms Xavier Becerra as U.S. Secretary of Health and Human Services

On March 18, Xavier Becerra was confirmed as Secretary of the Department of Health and Human Services on a [largely party-line vote](#). Becerra served 12 terms in Congress before his election as Attorney General of California. After his swearing in, Secretary Becerra is expected to play a central role in the Administration's pandemic response, as well as working to advance its broader healthcare policy agenda including insurance coverage expansion and prescription drug pricing reform.

### Regulatory Reports

#### UnitedHealthcare Announces Changes to Optum Pay

In an effort to support more small businesses through the Paycheck Protection Program (PPP), the U.S. Small Business Administration (SBA) is offering [PPP loans](#) to businesses with fewer than 20 employees and sole proprietors **only** now through Tuesday, March 9, 2021, at 5:00 pm (ET). [Additional program changes](#), designed to make access to PPP loans more equitable, were recently announced as well.

#### CMS Increases Medicare Payment for COVID-19 Vaccine

On March 15, [the Centers for Medicare & Medicaid Services \(CMS\) announced an increase, effective immediately](#), to the Medicare payment amount for administering the COVID-19 vaccine. The new payment amount of approximately \$40 per administration is nearly double the amount previously reimbursed, including administration of vaccines requiring two doses. The exact payment rate for administration of each dose of a COVID-19 vaccine will depend on the type of entity that furnishes the service and will be geographically adjusted based on where the service is furnished. The updated Medicare payment rate reflects the additional resources necessary to ensure the vaccine is administered safely and appropriately. These costs are described by CPT code 99072 and are now bundled into the new COVID immunization administration payments.
