AAO-HNS Celebrates House of Representatives Passage of Anti-Tobacco Legislation

Over the course of the past year, <u>the AAO-HNS collaborated with a number of physician and public health</u> <u>organizations to advance H.R. 2339</u>, the "Reversing the Youth Tobacco Epidemic Act." H.R. 2339, which was introduced by Representatives Pallone (D-NJ) and Shalala (D-FL) on April 18, 2019, would prohibit all flavored tobacco products, including e-cigarettes, increase the minimum age for purchasing tobacco products to 21, ban all non-face-to-face sales for tobacco products, and protect kids from the marketing of tobacco products. H.R. 2339 was marked up by the House Energy and Commerce Committee on February 21. The U.S. House of Representatives then passed the "Reversing the Youth Tobacco Epidemic Act" by a vote of 213-195 on February 28. The AAO-HNS and other coalition members continue our advocacy efforts in the U.S. Senate, where the bill has now been sent for further consideration.

Legislative & Political Reports

Federal Government Takes Action to Combat Coronavirus

Last week, Congress and the Administration took action to pass an emergency coronavirus package. <u>H.R.</u> <u>6074, the "Coronavirus Preparedness and Response Supplemental Appropriations Act"</u> passed Congress and was signed into law by President Trump on March 6. H.R. 6074 includes \$8.3 billion of funding for federal agencies to respond to the coronavirus outbreak. This funding will go toward public health measures to prevent the spread of this virus, develop vaccine and treatment, issue loans for affected small businesses and support health systems in other impacted countries. AAO-HNS applauds Congress and the Administration for their swift work to help keep Americans safe and alleviate this growing problem.

Reminder: MIPS 2019 Data Submission Deadline is March 31, 2020

The data submission deadline for Merit-based Incentive Payment System (MIPS) eligible clinicians who participated in the 2019 performance period of the Quality Payment Program is a few weeks away. Data can be <u>submitted and updated</u> any time until 8:00 pm (EDT) on March 31. Data submitted will be reflected in the 2021 calendar year payment adjustment. Please note that this submission opportunity is only through the CMS QPP interface. For those clinicians reporting through the Reg-ent registry, please continue to work with the Client Account Support team to complete the data review and submission process via your Reg-ent MIPS 2019 dashboard. The ASLP Interstate Compact Has Landed

The Audiology and Speech-Language Pathology Interstate Compact (ASLP-IC) legislation has been introduced in eleven states to date. The Academy has been working with the AMA, state otolaryngology societies and state medical societies to amend the legislation. These amendments include eliminating potential SOP expansion, increasing transparency, allowing physicians to be delegates to the Commission and redefining telehealth. <u>Be Advocate Aware!</u>
