# Candidate for Nominating Committee Academic – seat two

What experiences have you had that will allow you to identify a diverse set of candidates for Academy leadership? What are the most important attributes you look for when nominating a member for leadership within the Academy?

I have been fortunate to work with a tremendous number of otolaryngologists as an AAO-HNS leader. I have served in many roles, including Chair for the Section for Residents and Fellows-in-Training and later as Chair for the Young Physicians Section. I have also served as Associate Editor for *Otolaryngology– Head and Neck Surgery* and am the current CORE Grants Head and Neck Subcommittee Chair. In years of service, including eight years in elected Academy positions, I have worked with otolaryngologists of different race, gender, religion, ethnicity, practice type (private or academic), and experience (students, residents, fellows, junior faculty, seasoned faculty, chairpersons). This broad range of experiences have introduced me to so many diverse physicians. I have found such strength in the diversity of our specialty and all the persons who contribute. I am confident I can help identify a diverse group of future leaders for leadership consideration in the AAO-HNS.

Commitment to mission and integrity are the two most important attributes for Academy leaders. Leaders need to have a track record of volunteerism and service investment to the AAO-HNS, upholding and forwarding our collective mission of promoting and supporting otolaryngologists. I will look for candidates who have demonstrated, in both word and deed, these attributes. Involvement in the American Academy of Otolaryngology-Head and Neck Surgery (AAOHNS) has been a core part of my professional life since residency. While a resident, I served four years in elected positions within the Section for Residents and Fellows (SRF) including Information Officer, Vice-Chair, Chair, and Immediate Past Chair. Following residency and fellowship, I became involved in the Young Physicians part of AAOHNS, at that time as a committee member. After its conversion to the Young Physicians Section (YPS), I served four years in elected leadership including Secretary, Chair-Elect, Chair, and Immediate Past Chair. Since that time I have continued my involvement in AAOHNS in multiple capacities, including membership in multiple AAOHNS committees, serving as Associate Editor for the White journal, and serving over ten years as a Centralized Otolaryngology Research Efforts (CORE) reviewer. With eight years in elected leadership positions in both SRF and YPS, I have experienced the breadth and depth of AAOHNS's efforts with residents/fellows, young physicians, research, the Board of Directors, and the Board of Governors. I have previously been recognized for my years of service in AAOHNS with an AAOHNS Honor Award in 2013, and the AAOHNS Distinguished Service Award in 2019

I have seen the tremendous value AAOHNS brings to the specialty of Otolaryngology over my almost twenty years of membership. For the resident, it offers a focal point for meeting similar trainees and networking. For the young physician, it is a place to meet new peers and seek resources and learning to grow as a newly minted attending physician. For the busy established physician, it offers so many ways to support ones growth and practice – legislative efforts, reimbursement efforts, coding and RVU evaluation, practice management, social media, quality metrics, to name a few. It also offers continuing education to keep physicians current. As we are all lifelong learners the AAOHNS offers many educational resources to its members –clinical practice guidelines, the AAOHNS national meeting, FLEX and Oto source. There are so many ways that the AAOHNS is an amazing organization that supports its membership.

This organization with its multitude of priorities and goals needs a diverse team of experienced leaders to steer and execute its mission. The nomination committee serves to identify and solicit members of varied strengths and backgrounds to produce a diverse slate of leadership candidates to meet the needs of our complex organization. As a NomCom member, I would seek to identify a diversity of candidates for consideration. I would consider diversity of demographics – including age, ethnicity, gender. Additionally, I would seek leaders amongst a diversity of leadership backgrounds. In addition to practice diversity (academic private, hybrid), I would also seek candidates who have led in the AAOHNS, in subspeciality societies, or in their own hospital system and community. I would seek the broadest range of potential leaders for consideration, and then work with my NomCom peers to prioritize candidates that have shown the committed stewardship that align with the values of AAOHNS. My recent leadership in AHNS, as well as my long leadership experience in AAOHNS, has given me exposure to a broad range of leaders in our specialty for consideration. I hope to serve the Academy by helping select its future leaders.

#### Summation of Published Works Within the Specialty:

I currently have over 50 peer reviewed publications nearly all within the specialty of Otolaryngology-Head and Neck Surgery. I also have six book chapters. My publications are focused predominantly on head and neck cancer. My primary interest is focused on racial disparities in head and neck cancer. We have published multiple papers including evaluating discordant HPV/P16 oropharynx cancers in the African American population and evaluating germ line signatures predictive of response to therapy in Blacks vs. Whites with head and neck cancer. Additionally, I have published numerous publications with national database studies, evaluating clinical questions using the National Cancer Database. For example, we recently published a paper showing the impact on survival of positive margins in early oral cavity cancer.
