As the national medical association of physicians dedicated to the care of patients with disorders of the ears, nose, throat (ENT), and related structures of the head and neck, our members provide hearing-impaired patients with a full medical evaluation, diagnosis, and treatment for their hearing disorders.

As healthcare reform-related efforts continue to evolve, it's clear that providing a pathway for strong and efficient team-based care remains a tenet for all future healthcare delivery systems. The AAO-HNS supports the professional skill and training of our audiology colleagues and strongly believes a physician-led hearing healthcare team with coordination of services is the best approach for providing the highest quality care to patients.

Your legislation, H.R. 1116, the Medicare Audiology Services Enhancement Act of 2015, appropriately strengthens the structure for hearing healthcare services in the United States by better aligning Medicare coverage of comprehensive audiology services with current billing and reimbursement standards of other non-physician therapeutic services covered by Medicare (PT, OT, SLP).

The AAO-HNS applauds and joins you in your recognition that patients are best served within a collaborative team-based setting and appreciates the inclusion of the following provisions in H.R. 1116:

- Retention of physician referral requirements;
- Recognition that physician oversight of care plans is a critical aspect of quality hearing healthcare services; and
- Reiteration that the audiology services outlined in the bill adhere to existing scopeof-practice requirements as defined in each state.

In appreciation of your sensible approach to expanding audiology services, the **AAO-HNS** is pleased to again offer its support of H.R. 1116. The AAO-HNS and some
